The Committee reported back to council that there is no room to widen Weir's Lane. There was some discussion regarding pegs and boundaries, Mrs. Weir was informed that council does not get involved with personal boundaries. There was also some discussion regarding snow clearing of Weir's Lane.

	Center. The cost for the town to have area subdivided and the cost of legal

	price.
