#		ITEM
1		Mayor Lee brought the meeting to order at 6:45pm.
2		Minutes of June 4, 2018 were read. Motion #213 Harry Chafe/Rick Raymond Proposed minutes of June 4, 2018 be approved. All in favor, motion carried.
	BUSINESS ARISING	
3		#4 Staff is still investigating if signs are required for speed bumps.
4		#9 Staff have not heard anything back with regard to the letter that was sent regarding the sewer holding tank. Staff will call the property owner to inquire about the holding tank.
5		#11 The Street sign for Long Run Road has been purchased. The new sign will be placed on the post at the bottom of Long Run Road. This post currently has a sign for Southside Road. Staff will contact St. George's Church to see if the town can place the Southside Road street sign on the fence in the area.
6		#13 Dan Hynes and staff will be increasing the pressure in Maddox Cove on Wednesday, June 20 th . It was originally scheduled for Tuesday, June 19th but had to be changed due to scheduling issues.
7		#17 Councillor Green noted that the grass has not been cut at the War Memorial and is in bad shape. Councillor Green asked if the council would consider having Environmasters add the War Memorial to the current contract for lawn care. Stephanie Stack noted that staff has been very busy as there are only two workers. Mayor Lee noted that the grass would be cut for the July 1st ceremony.
8		#33 The CAO noted that they received a quote for the large town flags in the amount of \$100.05 each. Motion #214 Dave Green/Rick Raymond Proposed to cancel order for large flags. All in favor, motion carried. Councillors will be given a small flag. Staff will place a notice in the newsletter letting residents know the cost of the small flags and will note that they will be sold at cost.
9		#39 The area at the bottom of Big Hill that needed to be barricaded off was investigated and it is private property. Council will not be placing a barricade there at this time.
10		#43 Mayor Lee was speaking to the owner of the retaining wall on Motion Bay Road Extension. The property owner stated that he will pass this over to his insurance company. He also noted that it may be possible to come to some sort of agreement with the insurance company to move the water line instead of removing the retaining wall.

Councillor Raymond noted that in the past there was a clean out in the area of Todd Chafe's and Jerry Doyle's. There was also some discussion with regard to creating a new ditch. Mayor Lee noted that there is cliff in the area and could pose a problem with creating a ditch.
