| 1  |                     | Mayor Doyle brought the meeting to order at 6:33pm.  |
| 2  |                     | Minutes of March 7, 2022 were tabled.  Motion #54 Rick Raymond/Agatha Stack-Balsom  Proposed to accept the minutes of March 7, 2022. All in favor, motion carried.   |

| 3  |                     | #4 Condition of home at 6A Long Run Road The town received an email from the property owner stating that he is in the middle of getting the estate finalized after a death in the family. The property owner noted that the repairs should be completed by the end of the year. Council had some concerns that this was a long time to have the repairs completed. Council will place this item on the agenda for June to see what progress has been made with the repairs.  |
| 4  |                     | #10 The fridge magnets with the garbage and recycling schedules have been ordered.  They will be sent out in the mail to residents along with a "Recycling Starter Kit".   |
| 5  |                     | #23 The town received a Come Home Year Grant in the amount of \$2000.00. Staff priced the cost of having the berm at the look-out in Maddox Cove hydro-seeded. The cost is .90 cents per square ft. This includes topsoil and hydro seeding. This will be completed in the spring.   |

There was some discussion on the best location for the library. It was noted that a location can be determined if/when the library is constructed. |    | Proposed for the town to cover the cost of the materials to construct the "Free Little Library". All in favor, motion carried.   |
| 12 | Letter from resident of Pack's Lane with regard to the condition of the laneway. The Inspections and Development Committee and staff were on site to look at the area. Councillor Dyke noted that the laneway does need some work done. He stated that there are a few rocks protruding up through the laneway and some of the resident's grass has been torn up. Councillor Dyke asked if this is a town road or a right of way. Councillor Dyke noted that according to the survey it is a right of way. There was some discussion with regard to the town maintaining these types of right of ways. It  |
|    | was noted that this right of way has been plowed and maintained for a long time. Councillor Dyke asked if the town could get a quote on paving the area. Mayor Doyle stated that he could not see why we would need to get a quote on paving as this would not be something the town could afford. Mayor Doyle also noted that there are a number of unpaved roads in the town and they would all like to have them paved. Mayor Doyle stated that the town could repair the road in the spring and bring it back to its original state.   |
|    | Motion #61 Ed Dyke/Agatha Stack-Balsom Proposed to repair the road in the spring and bring back to its original state. All in favor, motion carried.   |
| 13 | Email from resident with regard to Hannaford's Lane. Councillor Stack-Balsom noted that she visited the area and felt that the road was in very good condition. She stated that there were a few small potholes that needed to be filled in but other than that it was in good shape. Councillor Dyke noted that he also visited the area and felt the road was in good condition except for a couple of small potholes. Councillor Raymond noted that there was a large boulder in the drain in the area and asked if staff could check into this. Mayor Doyle noted that paving a road like Hannaford's Lane would be a huge financial undertaking for the town as Capital Works Projects only cover 50% of the cost of these types of projects. Staff will send a letter back to the resident informing them that the town will be fixing up the potholes in the road but is not looking at paving this area at this time.  |
|    | <ul> <li>Foreperson's Report</li> <li>The Foreperson's Report was tabled</li> <li>Repairs to lift station - The Capital Works Project for the Lift Stations has been awarded. The project will start within the next two weeks.</li> <li>Repairs to Chlorine Station - Atlantic Technical will be installing a new pump at the chlorine station. Councillor Dyke asked what the cost of this pump would be. Staff will get back to him on this.</li> <li>Water Quality - the foreman issued a report on the water quality testing that Service NL completed this week. As per the results from the test, it has been determined that the discoloration in the water is coming from the pond. The town is planning on doing more investigation and testing to determine if this is just being caused by the strange winter weather this year or if there is an issue with the pond. Staff will do a visual inspection of the area around the pond to see if ATV activity in the area of the pond is causing an issue with possible runoff. They will also do more testing at the pond and possibly do an inspection of the intake valve.</li> </ul> |

Councillor Rowe stated that she felt it would be a great addition to the town. Councillor Rowe will send the application to staff to get the particulars on the requirements of the grant.   |

It was noted that during the last meeting with the Development Corporation, both parties agreed that the Development Corporation will move forward with the design work for the park and they will get back to council when they have this complete.   |
