16		Letter from resident with regard to crush stone that is piled up on the lane that leads to the power plant and also condition of the edge of resident's driveway. There was also concern with regard to a pipe/culvert that is protruding through the pavement on Skinner's Hill. Resident also voiced concerns about debris that is piled up next to home at 31 Main Road, Petty Harbour. It was discussed that the issue with regard to the crush stone will be
		dealt with during regular Spring maintenance as this issue with snow clearing and the piling up of crush stone happens every year in the lanes throughout the Town that do not have asphalt.
		Council is looking into the pipe/culvert that is protruding through the road on Skinner's Hill. This work may be completed during the road construction on Cribbies Road. Council is getting a price from the contractor to have this culvert/pipe replaced.
		The owner of 31 Main Road, Petty Harbour has started to remove the debris that is piled up next to the home. Council will give owner until the next Council meeting, if the debris is not all removed by then they will look into taking further action.
		Staff will send letter explaining all the issues with the complainant.

Cribbies Road reconstruction is to start on May 23, 2016, this project will take 4 – 5 weeks to complete. Big Hill Project will start immediately following the Cribbies Road Project and should take about a week to complete. The Water Main Project in the Power House river will follow immediately after the Big Hill Project.	
23	Mayor Hutchings and staff received a request from a business owner on Big Hill Road to have the Big Hill Road project start prior to Cribbies Road Project. Staff will send letter to business owner notifying him that Cribbies Road project is a priority and this project would have to start first.
