6		Letter regarding 10D Main Road Stop Work Order. Council met with the owner of 10D Main Road and it was noted that more time was needed to get the plot plan competed on the property as council had requested. There was some discussion as to whether Deputy Mayor Raymond was in a conflict of interest. Motion #286 Ed Dyke/Beatrice Burry Proposed that Councillor Raymond is not in a conflict of interest regarding matters of 10D Main Road, Petty Harbour. All in favor, motion carried. Councillor Raymond did not vote on this matter.
:		Motion #287 Ed Dyke/Melissa Pardy Proposed to grant a three week extension to the owners of 10D Main Road, Petty Harbour to submit a professional plot plan to council for review. Staff will contact the owner of 10D Main Road, Petty Harbour after 1 week to get a progress report. All in favor, motion carried.
7		Application to excavate land at 24 Cribbies Road (A2022-61). Deputy Mayor Raymond and Councillor Burry left chambers at 6:44pm due to a conflict of interest. The inspections & Development Committee visited the area and noted that they had no issues with the proposed excavation but did not want the neighboring brook altered in any way. Motion # 288 Ed Dyke/Agatha Stack-Balsom Proposed that the application to excavate at 24 Cribbies Road be approved with the stipulation that the brook in the area not be altered in any way. All in favor, motion carried.
8		Deputy Mayor Raymond and Councillor Burry returned to chambers at 6:46pm. Application to build a fence a 3 O'Brien's Lane (A2022-59). The Inspections & Development Committee visited the area and noted that there was no issues. Motion #289 Melissa Pardy/Rick Raymond Proposed to approve the application to build a fence at 3 O'Brien's Lane. All in favor, motion carried.

9	Resolution to apply for the cost-shred funding through the 2023-2024 Municipal Capital works.
	Motion # 290 Moved by Rick Raymond/Ed Dyke BE IT RESOLVED to apply for cost-shared funding through the 2023-2024 Municipal Capital Works Call for Applications with the Municipal Infrastructure Division of the Department of Transportation and Infrastructure, in the amount of \$140,000.00, for the purpose of Storm Runoff Remediation and Mitigation for Shore Lane. The Town of Petty Harbour/Maddox Cove agrees to provide its share of the cost-shared funding for this project should it be selected for funding and acknowledges that project costs above the approved project total cost will be the sole responsibility of Town of Petty Harbour/Maddox Cove. All in favor, motion carried.
10	The Site Specific Safety Plan was presented to council. The Department of Transportation and Infrastructure requires that this plan be adhered to for the pickup of ice control materials by all contractors. Motion #291 Ed Dyke/ Irene Stack Proposed to approve the Site Specific Safety Plan. All in favor, motion carried.
11	Email regarding industrial container at 59 Main Road, Maddox Cove. There was some discussion regarding the regulations for commercial property in residential areas. Motion # 292 Rick Raymond/Ed Dyke Proposed to defer any decision on the matter until the next meeting of council so that council can get a clearer understanding of the regulations regarding this matter. All in favor. Motion carried.
12	Proposed amendment by the Town of Portugal Cove- St. Philips to the St. John's Urban Region Regional Plan. The Town of Portugal Cove-St. Philips is requesting to rezone an area of land in their boundaries from rural to residential. Motion # 293 Ed Dyke/ Irene Stack Proposed to send a letter stating that the Town of Petty Harbour-Maddox Cove does
13	not foresee any issue with this re-zoning request. All in favor, motion carried. A quote was presented to council from CBCL Ltd. to complete a costing of the
	splashpad/ playground upgrades in Maddox Cove in the amount of \$15,660 plus HST. Motion # 294 Ed Dyke/ Melissa Pardy Proposed to accept the quote from CBCL in the amont of \$15,660 plus HST with the stipulation that an extension is given on the funding deadline of November 2022. All in favor, motion carried. Staff will ask the engineer about the water usage and chlorine usage of the splashpad.
	Request from Recreation to replace a door and doorbox at the community centre. A quote was received from Kent in the amount of \$258.92. Motion # 295 Melissa Pardy/Beatrice Burry Proposed to accept the quote in the amount of \$258.92 and replace the door and doorbox in the community centre. All in favor, motion carried.
15	Letter regarding suspected business at 10C Main Road, Petty Harbour. There was some discussion on the difficulty monitoring online businesses. Staff contacted other municipalities who are having the same issues. Motion #296 Agatha Stack-Balsom/Irene Stack Proposed to send a letter to the resident/proposed business owner asking if he is operating a business. All in favor, motion carried.
16	Letter regarding property taxes for 29-43 Shore Lane. The owner noted that the property is currently before the courts requesting a quieting of titles and is requesting that taxes be deferred until the matter is settled in court. 25		Council was reminded of the Town Hall Meeting that is scheduled for November 3 at 7pm at the community centre. It was noted that a sound system would be required. Auditors have noted that the bulk of the work has to be done in year one and makes bidding on single year contracts unappealing.
