PRESENT: Sam Lee, Sam Stack, David Green, Kim Orren, Lynn Hearn, Rick Raymond and Stephanie Stack

ABSENT: Harry Chafe

#		ITEM
1		Mayor Lee brought the meeting to order at 6:34pm.
2		Minutes of August 30, 2021 were tabled. Councillor Raymond arrived late at 6:41pm.  Councillor Orren noted that she would like an addition to #26 of the minutes. She stated that she questioned his relationship between the author of the letter and a petition that was tabled to council with regard to a fence at 10D Main Road, Petty Harbour and the response from Councillor Raymond at the last meeting was "none of her business". Councillor Orren stated that she would like this added to the minutes. Councillor Orren stated that she brought this up at the last meeting as she had a concern over a conflict of interest. Mayor Lee stated that at the last meeting the conversations became heated and he tried to keep order as the discussions were becoming personal. Mayor Lee also stated that he did not realize that Councillor Orren brought this issue up because of conflict of interest because at the time the discussion was not about the fence at 10D Main Road, Petty Harbour. It was agreed that if Councillor Orren had an issue with regard to this, that she bring it up under new business.  Motion #255 Sam Stack/Lynn Hearn  Proposed minutes of August 30, 2021 be approved. Mayor Lee, Deputy Mayor Stack, Councillor Raymond, Councillor Green, Councillor Hearn in favor. Councillor Orren not in favor. Motion carried.
	BUSINESS ARISING	Councillor Orien not in lavor. Motion carried.
3		#3 The fence and guard rail at the parking area off Skinner's Hill has not been completed but is on the list for staff to complete.
4		#4 The sand underneath the guard rail by the Co-op is not completed yet.
5		#5 Paving – There are a few small patches left to complete.
6		#6 The Commissionaires - ticketing Deputy Mayor Stack asked how much notice is required to hire the Commissionaires for ticketing. Staff will check into this. Mayor Lee noted that if they were hired in advance for the month of July then there should be no issue. Councillor Green asked if the town could hire two ticketing/traffic enforcement officers over the summer. Mayor Lee stated that town staff can issue tickets when needed and should be issuing a few random tickets in order to deter people from parking illegally. It was noted that the next council can look into this.
7		#7 The sewer overflow will be repaired once the storage container in the area is removed.
8		#10 Councillor Hearn noted that the rodent issue at 33 Motion Bay Road is still an issue. Staff will send a letter to the property owner.
9		#11 The town's part-time staff will look after the security for the municipal election on September 28, 2021.
10		#12 The gravel/crush stone has been shoveled out of the culverts.
11		#17 Councillor Green noted that the minutes of August 30, 2021 had a typo in #17 line 8. The "the" should be replaced with "he".
12		#19 Condition of property at 36B Long Run Road, Petty Harbour The town received an email from the property owner stating that because of Hurricane Larry his plans to have the property cleaned up were delayed. He asked council for an extension to the order. Councillor Orren stated that maybe council should give the 30 days from the date of the order since there was a recent hurricane. Mayor Lee noted that the property owner has had two weeks and nothing has been done.  Motion #256 Sam Stack/Kim Orren

		Proposed to give an extension to the order until the morning of September 20, 2021.  All in favor, motion carried.
13		#21 Repair to guard rail on Skinner's Hill This is on the list to have completed. Deputy Mayor Stack noted that the guard rail had to be fixed but is not an immediate priority at this time.
14		#27 A letter was sent to businesses regarding garbage around the community.

15		Request to speak from Jerry Hearn with regard to speed bumps on the Main Road. Mr. Hearn was present in chambers to speak. Mr. Hearn stated that there is high volume traffic in the area from the bridge to the point on the Main Road. He stated that he was speaking to the town of Logy Bay-Middle Cove and they informed him that they had hired a consultant (Harbour Side Consulting) that completed a study on traffic in their area. Logy Bay -Middle Cove then contacted the Department of Transportation and Infrastructure to request speed bumps in their area. Mr. Hearn stated that they were approved for speed bumps. Mr. Hearn also stated that Logy Bay – Middle Cove are looking at increasing the number of speed bumps. Councillor Green noted that he brought up the topic of speed bumps a couple of years ago and the Department of Transportation and Infrastructure were contacted. At that time, the town was told that the department would not be placing speed bumps on the main road throughout the community. Councillor Green suggest that the CAO contact the town of Logy Bay-Middle Cove to investigate this.
16		Application to operate a Vinegar Manufacturing Business at 35 Southside Road (A2021-32)  Mayor Lee and Councillor Hearn left chambers due to a conflict of interest at
		7:12pm. A letter from the business owner with points regarding parking was tabled. Deputy Mayor Stack noted that he inspected the original parking spaces that were noted on the application and stated that these spaces were not sufficient because they were on the shoulder of the road. Councillor Orren stated that the business owner lives in the town and would be walking to work and would not need a parking space for herself. Deputy Mayor Stack stated that he did not see an issue with this business using a few of the spaces at the Co-op but noted that these spaces were allotted for another business.
		Motion #257 David Green/Rick Raymond Proposed to send a public notice out to the public for comment. The notice will note the following: -that the business is primary a manufacturing business -it is only 240 sq. ftit will not be open regular business hours
		-it is artisan studio -the owner/operator will be walking to work and not requiring a parking space - there is one designated parking space allotted at the Co-op All in favor, motion carried. Mayor Lee and councillor Hearn returned at 7:25pm

28		Councillor Hearn noted that recreation had to get the cleaner in to clean the centre before it was booked out. She was wondering if the town would cover this cost as the town had been using the community centre for meetings for the last year or more. Deputy Mayor Stack asked if the rental cost would cover the cost of the cleaning.  Motion #269 Sam Stack/Rick Raymond  Proposed to cover a one-time cost to have the community centre cleaned. All in favor, motion carried.	
29		Councillor Hearn asked if there was any news on the Capital Works Project. The CAO noted that she received an email from the Department of Transportation and Infrastructure - Municipal Infrastructure Division stating that the town's Capital Works Application requires a climate lens to be completed to be considered for funding under the ICIP program. There were a number of questions and information that needs to be collected for this climate lens. Dynamic engineering will be contacting the department to have these questions answered.	

30	Deputy Mayor Stack noted that the Tidy Towns sign is Maddox Cove was blown down in the storm. Staff will look after this

Deputy mayor Stack suggested that the town cover half the cost of the Mayor's cell phone bill. Councillor Hearn agreed with purchasing a cell phone. She noted that when the Mayor is out of town it can be passed on to the Deputy Mayor. The CAO noted that communication between the town office and the Mayor is a regular daily occurrence. She noted that the Mayor is contacted several times a day.

She noted that she was asking this because of a potential conflict of interest for Councillor Raymond and she wanted to make council aware of this. Mayor Lee noted that when this was brought up in the last meeting it was brought up during a discussion on a different matter and it did not register to him what Councillor Orren was trying to say. Councillor Orren stated that she asked about this relationship and the discussion became heated and the issue was dropped. Councillor Orren noted that she done her duty of care by bringing it forward. It was noted to Councillor Orren that if she wanted to move forward with a conflict of interest complaint that she would have to forward a written complaint either to the council of the Department of Municipal and Provincial Affairs.
